

**South Granville Water and Sewer Authority (SGWASA), North Carolina**  
**Adopted Annual Budget Ordinance**  
**Projected Revenues and Expenditures**

**BE IT ORDAINED** by the Board Members of SGWASA, North Carolina

**Section 1:**

It is estimated that the following revenues will be available in the Water and Sewer Fund for the fiscal period beginning July 1, 2017 and ending June 30, 2018.

The water sales and sewer use charges were estimated using a revenue increase of 0% for water, 0% for sewer, and \$0.00 for capital, effective July 1, 2017.


